## RECORD OF PROCEEDINGS

October 10, 2022

The Council of the Village of Coldwater held its regular meeting in the Village Council Chambers on October 10, 2022, with mayor Doug Bertke presiding. The meeting was called to order at 7:00 PM.

Roll call was responded to by: Bettinger, Niekamp, Davis, Buschur, Seitz and Rutschilling.

Invocation by Davis.

A motion was made by Niekamp, second by Buschur to approve the minutes from September 26, 2022. Roll call resulted in the following ayes: Niekamp, Davis, Buschur, Seitz and Rutschilling. Bettinger abstained. Motion Carried.

Comments from the Public: Members of Cub Scout Pack 96 spoke about a project they completed over the summer. They constructed a wooden bench which sits on cinder blocks and will be placed at the Coldwater Nature Preserve. It took the group about 4 meetings to complete the project.

Police: None

## New Business:

Ordinance 1713: An ordinance accepting the plat of Eastpoint Estates Fourth Addition to the Village of Coldwater, Ohio; accepting the dedication to public use of the streets shown on said plat and declaring an effective date. Ordinance 1713 received its first reading.

Bids were received on October 6, 2022 on the Wetland Park. The low bidder was Kahlig Dozing and Excavating Inc. and the bid amount was \$80,609. A motion was made by Davis, second by Buschur to accept the bid. Roll call resulted in the following ayes: Bettinger, Niekamp, Davis, Buschur, Seitz and Rutschilling. Motion Carried.

Thomas offered thoughts and prayers to the Lou Brunswick family. Lou passed away recently and had previously worked for the Village of Coldwater at the park for many years.

Bettinger inquired about having a meeting to discuss empty lots in town that do not have sidewalks. Thomas said we will schedule a Transportation Committee meeting in the near future.

Bertke said there is an area on South Street that could use some cold patching. Thomas will look into it.
