Old Business:

Ordinance 1721: An ordinance establishing certain positions and a pay schedule for hourly and salaried employees of the Village of Coldwater, Ohio; providing for employee benefits not otherwise specified in the personnel policies manual, repealing all ordinances inconsistent herewith and declaring an emergency. Ordinance 1721 received its third and final reading.

A motion was made by Bettinger, second by Niekamp to suspend the rules for Ordinance 1721. Roll call resulted in the following ayes: Rutschilling, Buschur, Niekamp, Bettinger, Davis and Seitz. Resolution 829: A resolution declaring the Village's intent to proceed to place on the November 2023 general election ballot a one-half mill (0.5) renewal levy for benefit of the Coldwater Public Library. Resolution 829 received its third and final reading.

A motion was made by Rutschilling, second by Seitz to approve Resolution 829 on its third and final reading. Roll call resulted in the following ayes: Rutschilling, Buschur, Niekamp, Bettinger, Davis and Seitz. Motion Carried.

Council Call-Final Comments:


